- Environmental Water Quality Monitoring and Enforcement/AEC approved for Little Lake they are coming this Thursday. Little Lake has 2 types of lily pads on the lake they will be treated along with the cattails. The North American pond weed has "exploded" in both lakes. This may have to be treated as well.
- There are serious concerns on the Big Lake with vegetation in the area by Kane, Churi, Hennemuth, LeStrange lot, etc. Lots of floating vegetation – new within the last year.
- John Foff noted that we need to survey the inlet, pins on Maple, West Shore, Spring (next to Giavagnoli's) and Mountain(on West shore Drive) on Big Lake, Sawmill and Laurel on the Little Lake as well as the outlet. Some of these surveys have already been done
