

Board Membership Meeting 6:00pm 10/11/2022 Zoom Call

In Attendance: Joe McGraw, Frank Kane, Jen Foff, Maggie Mariotti, Ruth Burke

Financials – Frank Kane

- Budget, AR, Balance Sheet, Check Detail, P&L
- Lifeguards costs were \$8,800.00 this year
- Titan Tree spent 10 days cutting down dead trees and opened up the canopy above the roads
- Snow removal is usually around \$14,000.00 depending on the winter weather
- Money Market account is a "reserve account" with about 6 months of working capital
- The women's club requested that the basketball court be repaved for a cost of \$4,500.00 with MLC monies. This will be put in to the 2023 budget in January for a spring paving. The women's Club offered to pay for new basketball hoops and also intimated that there is a member who would donate monies for a pickleball court drawn ON the basketball court
- New parcel boxes at the mailboxes for \$2750.00 as there are not enough PACKAGE boxes. This was approved by the board. Maggie Mariotti will order the box tomorrow
- Lighting was requested for the Community House Joe McGraw checked on the lights and they are functional. They are on timers Jeff Gentile will have to hook up the new light.
- Rinker gave us a bid for around \$11,000.00 for a generator at the Community Center. We do not have monies for this right now
- Fish Stocking: there has been a request to stock this year/ end of October, early November \$1,500.00 we only approved \$1,000.00 for a "fish structure" per Chris Luciani's request

Land & Lakes

- Unclaimed Boats at volleyball field to be discarded John Foff has checked the commons and there are 10 boats WITHOUT stickers. He spoke with Glen Lesh to take one of the boats out of the lake. The boats will be left next to the dumpster and need to be claimed by the spring meeting.
- Beaver: structure by John Hill/Kane and McGraw's. Trapper Don Kublick will be contacted to get rid of them "in season"
- Detached Garages/Structures are Prohibit unless located on a separately deeded lot
- Sheds are not endorsed by the board due to deed restrictions.
- Vulgar language, music, videos and inappropriate signage are prohibited political signage cannot be put on MLC property
- Leaf and wood burning must in a burn barrel and not interfere with any neighbor's enjoyment of their property. Trash burning is prohibited
- Request for 3 Handicap Parking Signs at Community Center Frank will get these
- Commons to be Surveyed and Documented. We have contracted LaBella surveyors to ascertain boundaries. 8 commons will be surveyed and a list of encroachments will be done. Joe is working with Chris Farrell, our attorney, to get a letter put together to inform members of any encroachments. How many properties are Lakefront? Jefferson Township MAY have surveys of our roads from when the sewers were put in??
