- Commons Surveyed and Documented. Encroachments must be corrected. Attorney needs to draft a notification letter and take appropriate action on behalf of members. John has meet with the surveyors and there are some issues – one on Maple Road has missing pins, some other are property owners encroaching on the Commons as well as Commons encroaching on the private properties

Environment - Ruth Burke and Alison McHale

- Environmental Water Quality Monitoring and Enforcement/AEC approved for Little Lake
- Ways to Love Your Lake Presentation May 2023
- Joe McGraw discussed
- fish stocking for the lake our costs are high to balance the waters to eradicate invasive species of fish and weeds that may be related to the stocking water.
- The structures that were put in the lake year ago are to allow the fish to multiply naturally. Stocking has been going on for at least 60 years.
- Live bait buckets have brought in weeds
- Stocking has become cleaner but the water that the fish are brought in has historically been the problem
- Recommendation on tree planting. Trees Planting not saplings. Can Ruth get some numbers on larger trees? We can then present the information to the lake
- Should we do the "Love the Lake" and the fishing group together in May? We can present numbers then. If Frank Capucci can monitor all of it, it might work.
- Alison has a solution for the geese SWANS are natural enemies and she has found plastic ones that can float in the lake Alison can price out "The Pond Guy" 2 for \$139.00
- AEC and Farnham Contracts Alison is doing the contracts for both companies now and will get numbers for the Little Lake as well.
